Official Rules**

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.

THE 104 GUN GIVEAWAY SWEEPSTAKES (“SWEEPSTAKES”) BEGINS ON 7/7/18 AND ENDS ON 10/31/18 (“ENTRY PERIOD”).

ELIGIBILITY: Sweepstakes is open only to legal residents of the 50 United States (excluding residents of the District of Columbia) age 18 years of age or older (or at least the age of majority as legally mandated by the entrant’s jurisdiction of residence if greater than 18) and who are legally deemed eligible to possess a firearm at date of entry.
